- Reciprocity: \$60 for any 10 days during the annual season. WVSC members only.
- SSA FAST Program: Purchase FAST voucher \$139. One hour lesson may be extended with special membership at \$50/month for a maximum of 3 months. New students only.
- Professional Consultant: No fee. Use of HRS aircraft permitted for consultant purposes only.

I agree to abide by all rules and operating procedures established by Hood River Soaring. I understand that aircraft fleet composition, dues, and rates may change when the Board of Directors deems it appropriate.

I may terminate my membership at any time by providing 30 days written notice. However, I understand that the initiation fee and dues I have paid are non-refundable.
